**CIRCULAR**

With prior approval of His Lordship Justice Shri A.H. Joshi, Hon'ble Chairman, Maharashtra Administrative Tribunal, Mumbai, certain changes are made in the prescribed format of notice issued by the court relating to time for collecting notice and for filing service report.

The changed last paragraph of notice shall be read as follows :-

“In case notice is not collected within **three days**, and if service report on affidavit is not filed **three days** before returnable date, Original Application shall stand dismissed without reference to Tribunal and papers be consigned to record.”

In case returnable date is longer than six weeks, time prescribed for collecting the notice shall be “**seven days**” instead of “**three days**”.

This order shall come into force with immediate effect.
